THE HOSPITAL IS COMPRISED OF AN ACUTE CARE FACILITY WHICH PROVIDES HEALTHCARE SERVICES. THE HOSPITAL PROVIDED 52,714 VISITS AND TREATED 11,632 PATIENTS DURING THE FISCAL YEAR.

THE HOSPITAL PROVIDES CARE TO PERSONS COVERED BY GOVERNMENTAL PROGRAMS AT AN AMOUNT BELOW COST, AND PROVIDES CARE TO INDIVIDUALS WHO ARE UNABLE TO PAY. THE UNREIMBURSED VALUE OF PROVIDING CHARITY (\$964,919) AND UNCOMPENSATED CARE (\$760,145) TOTALED \$1,725,064. UNPAID MEDICAL PROGRAM CHARGES WERE \$96,924,579. UNPAID MEDICARE PROGRAM CHARGES FOR THE FISCAL YEAR WERE \$47,613,567. THUS, TOTAL QUANTIFIABLE COMMUNITY BENEFITS PER AUDITED FINANCIAL STATEMENTS-NOTE Q WERE \$146,263,210.
